Originally built in 1935, this 26-foot-wide townhouse spans approximately 3,200 square feet with 6 beds and 3 full baths. It features a garden and terrace, a rooftop skylight, original hardwood floors, an open living and dining room, a fireplace with hardwood mantle, an original wooden grand staircase, custom windows with between-glass blinds, an updated deck with composite decking, private parking, and much more.

Also signed this week was Unit 3A at 50-01 5th Street in Hunters Point, with a last asking price of \$1,999,000. Built in 2009, this loft-style condo spans 1,542 square feet with 2 beds and 2 full baths. It features high ceilings, southwest exposure, bamboo flooring, an open chef's kitchen with stainless steel appliances, and much more.
