27 East 11th Street in Greenwich Village entered contract this week, with a last asking price of \$29,995,000. This 25-foot wide townhouse has been impeccably renovated and spans approximately 9,000 square feet with 7 beds and 10 baths. It features over 2,000 square feet of outdoor garden, 2 terraces, a roof deck, an elevator, wood-burning and gas fireplaces, radiant heated flooring throughout, a temperature-controlled wine cellar, a circular staircase, large skylights and windows, high ceilings, a custom kitchen with high-end appliances and remote-controlled cabinetry, a full-floor primary suite with Juliette balcony and spa-like bath, and much more.

Also signed this week was the Penthouse at 455 West 19th Street in Chelsea, with a last asking price of \$22,750,000. Built in 2019, this new development condo is one of ten boutique residences, and spans 3,794 square feet with 4 beds and 3 full baths. It features panoramic views of the river and the city skyline, an outdoor lounge area, a custom Danish-designed kitchen, a rooftop garden and swimming pool with private elevator access, and much more. The building provides a full-time doorman, concierge, cold storage, and many other amenities.
